Wholesale Dealer's Authorisation (WDA(V))

SECTION 1

- 1. The authorisation covers distribution by way of wholesale dealing of veterinary medicinal products by the authorisation holder named and storage of such products only on the premises specified.
- 2. The authorisation holder must provide and maintain such personnel, equipment and facilities as are necessary to avoid the deterioration of the veterinary medicinal products. If any change of premises is proposed prior approval must be sought from the Secretary of State. Any proposals to make structural alterations to the premises must also be notified to the Secretary of State. If the business should change hands, the company or person taking over the business will need to obtain their own authorisation, if they do not already have one, or vary and existing authorisation to include the additional site(s) before commencing wholesale dealing from these sites.
- If an authorisation holder intends to import and hold unlicensed products into the UK, an application for a
 wholesale dealer's import certificate must be made. These products may only be released to a veterinary
 surgeon who holds a certificate from the Secretary of State entitling him to use the product.
- 4. This authorisation does not cover any manufacture and/or assembly process (e.g. packing, filling or labelling) of veterinary medicinal products including the import of authorised products from outside the EEA. If you wish to conduct any of these activities an application for a manufacturing authorisation must be made and an authorisation granted for that purpose.
- 5. The name and address of holders of WDAs for veterinary medicinal products together with the addresses of authorised sites are published on the MHRA website www.gov.uk/mhra.
- 6. An authorisation may be suspended if any fees are not paid in full as they fall due.

8. Authorisation Structure

This authorisation is divided into three sections.

- (a) <u>Section 1</u> (this section) identifies the authorisation holder and holds the authorising signature. This section would not usually be replaced during routine variations of the authorisation unless the authorisation holder details are varied.
- (b) <u>Section 2</u> lists variations to the authorisation. A replacement section 2 will be issued each time the authorisation is varied.
- (c) <u>Section 3</u> contains the details relating to each site named on the authorisation. Where there is more than one site there will be more than one part to Section 3. When a variation is made to the details of a site named in Section 3 the relevant part of Section 3 will be replaced.
- (d) The authorisation holder is required to attach to his authorisation any replacement pages issued by the Secretary of State and to mark or destroy superseded pages as to render them invalid.
